The products do not contain paraffin of mineral oil origin. According to the protection of utility models (registered sample), synthetic wax (<3%) is used as a crystallization accelerator. Because products are mixtures, there is no unique CAS/EINECS number describing the products as a whole.

The grades of rapeseed oil used in the above-mentioned products are of European origin, including – in addition to members of the European Community – countries such as Ukraine and Russia. The products are adjusted by manufacturing appropriate to the intended application. It is possible to claim the European Community as the origin of products.

Rapeseed (seed) / canola is a historical crop in Europe from conventional cultivation. For all, there are no genetically modified organisms (GMOs) used for this plant.

These waxes do not have "organic" certificates, for example Ecocert. In addition, there are no raw materials from controlled organic crops or farms for the manufacture of designated products.

Partially and fully hydrogenated rapeseed comes from suppliers to the food industry. Nevertheless, the products are not intended as food, they are classified as unfit for human consumption (inedible). No recommendation or confirmation of their use as a food, food additive, food contact material or cosmetic ingredient can be provided.

The products in their composition comply with the requirements of RAL 041, quality mark candle, fastener 1, as well as EN71-3 (toys).
