1	Leave on products generally applied to lips Lip Products of all types (solid and liquid lipsticks, balms, clear or colored, lip wax, etc.) Children's Toys
2	Leave on products generally applied to axillae (or the body) Deodorant and/or antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deo-cologne aerosol spray etc.) Body sprays (including body mist)
