section 4

First aid measures

4.1 Description of first aid measures

General information:

In case of excessive inhalation, take the person to fresh air and keep them in a resting position. Consult a doctor.

Remove contaminated clothing immediately, wash skin with water and soap, and rinse thoroughly for at least 20 minute. Rinse mouth with water. Do not give anything to drink. Rinse immediately carefully and thoroughly with eye-bath or water.

6.1 Personal precautions, protective equipment and emergency procedures
