First aid measures

4.1 Description of first aid measures

General information:

In case of excessive inhalation, take the person to fresh air and keep them in a resting position. Consult a doctor.

If you wear contact lenses, remove them. In case of contact with the eyes, rinse the eyes thoroughly with water for about twenty minutes. If irritation persists, or if lesions appear, consult a doctor.

Remove contaminated, saturated clothing immediately.
After contact with skin, wash immediately with plenty of water and soap.
Take off contaminated clothing.
In case of skin reactions, consult a physician.

Following eye contact:

If you wear contact lenses, remove them. In case of contact with the eyes, rinse the eyes thoroughly with water for about twenty minutes. If irritation persists, or if lesions appear, consult a doctor.
In case of eye irritation consult an ophthalmologist.
Rinse immediately carefully and thoroughly with eye-bath or water.
Remove contact lenses, if present and easy to do. Continue rinsing.

Following ingestion:

Rinse mouth with water. Do not give anything to drink. Do not attempt to induce vomiting and call a doctor.
Never give anything by mouth to an unconscious person or a person with cramps.
IF SWALLOWED: Rinse mouth.
Do NOT induce vomiting.
